Application Requirements:

1. Artist must be an active member of The Cathedral Basilica of St. Francis of Assisi.
2. Work shown is original by the artist and completed within the past 2 years.
3. Artists will have no more than 5 pieces of art exhibited at one time.
4. Artists will deliver their pieces of art to the gallery at 213 Cathedral Place on the Thursday before the exhibit.
5. Gallery space will be assigned and artists will set up own art for exhibition prior to the the exhibit/sale.
6. Artists will be required to staff exhibition space during the exhibit/sale and provide refreshments.
7. A biographical package and photos of each piece of art to be exhibited must be included with the application.

Selection process:

For this first of series of fund raising art exhibits, space is limited, so early applications are encouraged

There will be a panel who will review artists applications and and sample of works to be exhibited. The Cathedral Basilica reserves the right to refuse any artists work at any time. Artists will be notified by the panel of acceptance/rejection of their works.

Agreement:

I/we hereby make application to become an exhibitor in an art show located at 213 Cathedral Place, property owned by The Cathedral Basilica of St. Francis of Assisi and previously used as parish offices. I we will receive 66.35% of any sales of my(our) artwork and this will be paid at the end of the exhibition.
